the undersigned do hereby FULLY RELEASE, FULLY WAIVE, FULLY DISCHARGE, AND COVENANT NOT TO SUE, the operators or Owner, its officers, directors, shareholders, employees, agents, managers, attorneys, subsidiaries, independent contractors, successor or assigns, (herinafter collectively referred to as "releasees") and each of them, from any and all claims, and/or the ordinary negligence of released, and/or the strict liability, and/or the negligence of any third party or participant, which causes the undersigned injury, death, personal injury, bodily injury, property damages, or any other type or kind of injury, and.or loss, and/or damages. The undersigned hereby convenants to hold "releasees" harmless from and to fully indemnify "releasees" for any type or kind of damages, judgements, awards, or related expenses (including but not limited to releasees' attorney fees and court costs) that "releasees" may incur as a result of the participation of the undersigned in any activity, and/or game, and /or match, and/or practices, and/or camps, and/or scrimmages, and/or leagues, conducted within Owners premises at any time.
